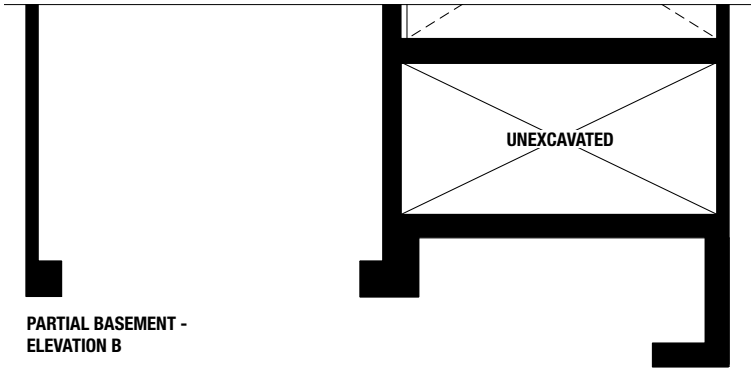
PARTIAL GROUND FLOOR -
